Sealed proposals will be received by the City of Hermitage, Mercer County, Pennsylvania at the City office located at 800 North Hermitage Road, Hermitage, Pennsylvania 16148 until 11:00 AM prevailing time on February 14, 2018, for:

2018 NEIGHBORHOOD INVESTMENT PROGRAM

The scope of work generally consists of approximately 3,800 SY of roadway, milling / profiling, variable depth Superpave HMA binder and 1½" Superpave HMA wearing course; 2,400 LF of new or replacement storm sewer; 42 storm inlets; concrete, stone and bituminous driveway adjustments; lawn restoration; traffic control; and all necessary appurtenances for said construction on Lyle Drive.

All work shall be constructed according to drawings and specifications which are on file at the office of the Owner and Lennon, Smith, Souleret Engineering, Inc.; 846 Fourth Avenue; Coraopolis, Pennsylvania 15108-1522. Bids will be publicly opened and read aloud approximately at 11:00 AM on February 14, 2018, at the City office. Sealed proposal should be marked "Contract No. 17-R01 – 2017 Neighborhood Investment Program".

Bid Documents are being distributed by F. L. Haus Company, 921 Ridge Avenue, Pittsburgh, PA 15212. All bidders are required to buy the full set of drawings and specifications for a non-fundable deposit of \$100.00 from F. L. Haus Company at www.flhausplanroom.com. A General Bidders Meeting will be held at the City Building, 800 N. Hermitage Road, Hermitage, Pennsylvania 16148, on January 31, 2018 at 10:00 AM.

Pennsylvania prevailing wage rates apply. Proposals must be upon the forms furnished by the City. The bid must be accompanied by a certified check or bid bond in the amount of ten percent (10%) of the bid, made payable to the City of Hermitage to guarantee the bidder's entrance into the contract if given the award. No bid bond shall be waived or returned because the Bidder has failed to or cannot comply with any requirements as set forth in the plans, specifications, or any applicable statutes of the State of Pennsylvania or any applicable municipal ordinances.

The City reserves the right to reject any or all proposals and to waive any informalities in the bidding. No bid may be withdrawn for ninety (90) calendar days after the scheduled time for receipt of bids.

Attention is directed to the fact that procurement is subject to all requirements of the Pennsylvania "Steel Products Procurement Act, Act No. 1978-3"; and for Contract value exceeding \$25,000, the Pennsylvania Prevailing Wage Act (Act of 1961 P.L. 987), and The Public Works Employment Verification Act (July 2012) apply.

The City shall (a) award the construction contract to the lowest responsible bidder therefore, or (b) reject all bids received within ninety (90) days of the date of bid opening; provided, however, that the City may, in its sole discretion, delay such award or rejection for up to one hundred twenty (120) days from the bid opening date until the City has received all required approvals from other governmental agencies.

Bidders on this work will be required to comply with Title VI of the Civil Rights Act of 1964.
