**2024 Capital Paving Program**

Bids for the construction of the Project will be received at the office of the City Manager, Hermitage Municipal Building located at 800 North Hermitage Road, Hermitage, PA 16148, **until April 12, 2024 at 10:30 AM** local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

Base Bid work consisting of milling and paving of approximately 9,025 SY of roadway on Jerry Lane, Fran Lane, Tiffany Lane, and a parking lot at the Wheatland Municipal Building.

Add Alternate 1 Bid work consisting of milling and paving of approximately 1,309 SY of roadway on Danielle Court.

Bids are requested for the following Contract: **2024 Capital Paving Program, Project No. 00100-2406.**

The Project has an expected duration of **30** days from the date of issuance of the Notice to Proceed.

### **Pre-bid Conference**

**A pre-bid conference for the Project will be held on Monday, April 1 at 10 AM at the City of Hermitage Municipal Building**, 800 North Hermitage Road, Hermitage, PA 16148. Attendance at the pre-bid conference is encouraged but not required.

### **American Rescue Plan Act (ARPA)**

The project is being partially funded by ARPA Coronavirus State and Local Fiscal Recovery Funds (SLFRF) and bidders are required to comply with all applicable federal statutes, regulations and executive orders including the Department of Treasury Coronavirus State and Local Fiscal Recovery Funds Interim Final Rule (to the extent a provision of the Interim Final Rule remains in effect), the Department of Treasury Coronavirus State and Local Fiscal Recovery Funds Final Rule, and the Uniform Administrative Requirements, Cost Principles and Audit Requirements for Federal Awards (Code of Federal Regulations "Uniform Guidance" or 2 CFR Part 200).

In accordance with the US Department of Treasury Final Rule, the City of Hermitage has elected to utilize the Standard Allowance for Revenue Loss which applies to all funds received by the City under the Act and intends to use all of its ARPA funds for the provision of Government Services.

In accordance with the US Treasury guidance the City requires project bidders to adhere to strong labor standards and pay workers at or above the Prevailing Wage Rates and strongly encourages the utilization of local hires.

### **Instructions to Bidders.**

For all further requirements regarding bid submittal, qualifications, procedures, and contract award, refer to the Instructions to Bidders that are included in the Bidding Documents. It is the proposing Bidder's responsibility to read the entire bid package and addenda and comply with all ARPA funding requirements.
