City of Hermitage (Owner) is requesting Bids for the construction of the following Project:

NORTH KEEL RIDGE ROAD IMPROVEMENT

Bids shall be submitted in a sealed envelope labeled North Keel Ridge Road Improvement Project and delivered to Hermitage Municipal Building, Attention: Gary Hinkson, City Manager, 800 N. Hermitage Road, Hermitage, PA 16148, Bids are due by **Thursday May 1, 2025 at 11:00 AM** local time whereupon bids will be publicly opened and read.

The Project includes the following Work:

This Project aims to make SR 3011 (North Keel Ridge Road) suitable for Joy Cone truck traffic. This will be accomplished by performing full-depth reclamation of the existing pavement and replacing with a pavement designed to manage the truck weight, providing 10' striped travel lanes with 2.0' shoulders, modifying the Joy Cone drives so that truck traffic can ingress and egress the driveways without having to cross the double yellow center line, and providing adequate stormwater management for the improvements within the right-of-way.

The Project has an expected duration of **[90]** days.

Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including addenda, if any, obtained from sources other than the Issuing Office. Pre-bid Conference

A pre-bid conference for the Project will be held on Wednesday April 23, 2025 at 10:00 AM at the Hermitage Municipal Building, 800 North Hermitage Road, Hermitage, PA 16148. Attendance is encouraged but not required.

Instructions to Bidders.

Refer to the Instructions to Bidders in the Bidding Documents for requirements on bid submittal, qualifications, procedure and contract award.

Each bid shall include a Bid Bond in the amount of not less than 10% of the total bid. A 100% Performance and Payment Bond is required for this work.

All bids are irrevocable for 60 days after the bid opening date unless award is delayed by a required approval of another government agency, the sale of bonds, or award of a grant or grants, whereupon Bids shall remain subject to acceptance for 120 days after the bid opening date as provided by the Act of November 26, 1978 (P.L. 1309, No. 317), as amended by the Act of December 12, 1994 (P.L. 1042, No. 142). Bids received after the stated time will be returned unopened.

The City reserves the right to waive any defects, errors, omissions, mistakes, informalities, to accept any bid or combination of bids that are deemed to be in the best interest of the City, and to reject any or all proposals. The City of Hermitage Advertisement and Procurement efforts provide for open and free competition among available bidders, and welcomes and encourages bids from disadvantaged, minority and women business enterprises.

Prevailing wages established under the **Pennsylvania Prevailing Wage Act** will apply to this contract. Contractors must follow applicable federal, state and local laws and regulations and program guidelines specified in the Contract Documents and the **PennDOT / PA DCED Transportation Infrastructure Investment Funding Reimbursement Agreement** Grant Contract entered into by the City of Hermitage, which is incorporated into the Contract Documents.
