**2025 Neighborhood Improvement Program**  
**Fern Street (Greenwood Avenue to Baker Avenue)**

Bids for the construction of the Project will be received at the office of the City Manager, Hermitage Municipal Building located at 800 North Hermitage Road, Hermitage, PA 16148, until Tuesday, June 25, 2025 at 10:00 AM local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

Installation of approximately 2,200 lineal feet of 15" diameter HDPE storm sewer; approximately 263 lineal feet of 24" diameter HDPE storm sewer; 35 PVC stormwater catch basins; 2 stormwater manholes; demolition of the existing stormwater facilities; milling approximately 3,467 SY of roadway; 477 tons of binder course asphalt and 3,467 SY of wearing course asphalt; asphalt, concrete and gravel driveway adjustments; site restoration and other minor improvements and restoration items.

The Project has an expected duration of **60** days.

## **INSTRUCTIONS TO BIDDERS**

For all further requirements regarding bid submittal, qualifications, procedures, and contract award, refer to the Instructions to Bidders that are included in the Bidding Documents.

Each bid shall be accompanied by a Bid Bond in the amount of not less than 10% of the total bid. A 100% Performance and Payment Bond is required for this work.

All bids shall be irrevocable for 60 days after the bid opening date unless award is delayed by a required approval of another government agency, the sale of bonds, or award of the grant or grants, in which case this Bid shall remain subject to acceptance for 120 days after the bid opening date provided the Act of November 26, 1978 (P.L. 1309, No. 317), as amended by the Act of December 12, 1994 (P.L. 1042, No. 142). Bids received after the stated time will be returned unopened.

The City reserves the right to waive any defects, errors, omissions, mistakes, informalities, to accept any bid or combination of bids that are deemed to be in the best interest of the City, and to reject any or all proposals.

Contract Documents contain requirements addressing prevailing labor wage rates, labor standards, and Steel Product Procurement Act and related matters.
