The Project includes the following Work:

Base Bid work consisting of milling and paving of approximately 7,563 SY of roadway on Tiffany Lane, Fran Lane, and Lee Run Road.

The Project has an expected duration of **30** days from the date of issuance of the Notice to Proceed.

Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including addenda, if any, obtained from sources other than the Issuing Office.

Printed copies of the Bidding Documents may be obtained from the Issuing Office by paying a deposit of **\$100** for each set. Make checks for Bidding Documents payable to IAG Consulting, LLC.

Bidding Documents may be purchased from the Issuing Office during the hours indicated above. Cost includes shipping charges. Upon Issuing Office's receipt of payment, printed Bidding Documents will be sent 2nd day mail service.

Pre-bid Conference

A pre-bid conference for the Project will be held on Thursday, June 12 at 10:30 AM at the City of Hermitage Municipal Building, 800 North Hermitage Road, Hermitage, PA 16148. Attendance at the pre-bid conference is encouraged but not required.

Instructions to Bidders.

For all further requirements regarding bid submittal, qualifications, procedures, and contract award, refer to the Instructions to Bidders that are included in the Bidding Documents. It is the proposing Bidder's responsibility to read the entire bid package and addenda.

Each bid shall be accompanied by a Bid Bond in the amount of not less than 10% of the total bid. A 100% Performance and Payment Bond is required for this work.

All bids shall be irrevocable for 60 days after the bid opening date unless award is delayed by a required approval of another government agency, the sale of bonds, or award of the grant or grants, in which case this Bid shall remain subject to acceptance for 120 days after the bid opening date provided the Act of November 26, 1978 (P.L. 1309, No. 317), as amended by the Act of December 12, 1994 (P.L. 1042, No. 142). Bids received after the stated time will be returned unopened.

The City reserves the right to waive any defects, errors, omissions, mistakes, informalities, to accept any bid or combination of bids that are deemed to be in the best interest of the City, and to reject any or all proposals.

Contract Documents contain requirements addressing prevailing labor wage rates, labor standards, and Steel Product Procurement Act and related matters.
