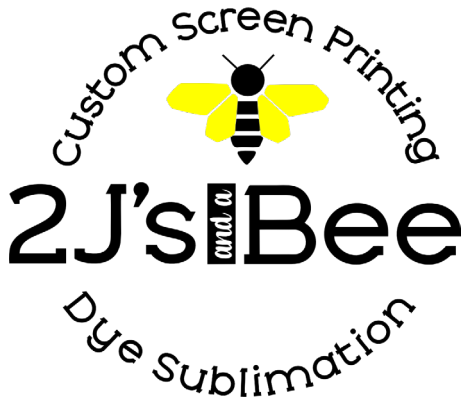

2J's and a Bee Can Do a Lot More than T-Shirts

When people think of screen printing, they think of T-shirts, said Laurie Phillips, owner of 2J's and a Bee, a screen-printing business at 1883 E. State St.

2J's and a Bee can do a lot more than T-shirts, Phillips said.

"We do hats and jackets and blankets and towels, license plates, lunch boxes," she said. "You name it."

Phillips also has learned a process called dye sublimation printing, a digital printing technique, that opens up new possibilities. She showed a pair of socks in a customer's school colors with his name and number on them, which were made with dye sublimation.

"I also kind of put myself in the crafting industry as well," she said. "So, I do a little crafting along with it, like, with mugs and the tumblers."

Phillips was working at a now-defunct local department store when she felt the need to do something different, and not something everyone else was doing, she said.

"Through prayer, God just kind of brought to fruition screen printing," Phillips said. "I knew nothing of it. Did not know how to do it."

This was the late 1990s and Phillips was already exploring graphic design computer programs. She read a how-to book – several times – and talked with local screen printers, who were willing to share their techniques with her. Taking money from a life-insurance policy to fund her start-up, she worked out of her home starting in 2000 and then from a storefront on Broadway Avenue in Farrell. The business next moved to space behind what was Bud

Miller's Kitchen and Bath, now G.H. Hurl Construction, in Hermitage.

Although Phillips left the industry for a while to become a registered nurse, "God called me back into the business," she said. "My faith and hope is in God. I have a relationship with God. When he speaks, I have to do what he says. Here I am."

2J's and a Bee has been at its present location since 2018.

"They always say location, location, location – I'm on East State Street," Phillips said. "I can't beat this location, the traffic. It's somewhat centralized. I really do like being in Hermitage."

The business name derives from three of her grandchildren: Jadon, Josiah and Brooklyn, who help her out in the shop. Her husband, Luther, also works there.

Phillips said she loves working with her customers, many of whom come in with vague notions about what they want her to do, she said.

"They'll come in with, 'I think I want this,' and might give me a sketch of something, and then I put it all together," she said. "There's joy in that, to serve the needs of the customers."

Phillips considers herself a servant – first, to God, and then, to others. With that frame of mind, she has started teaching others how to do what she does. She offers in-store and virtual classes, using design programs such as Canva and Photoshop.

"You want to teach what you know and pass that on," she said. "It's not a competition thing. It's out there. You

can't say, 'No, don't do my industry. I want to be the only one.' It's just not gonna happen. For those that want to learn, why not teach them?"

On June 14, Phillips and her husband launched a second business, The Laundry Man, a full-service laundry operation. "We come pick it up, wash it, dry it, fold it and bring it back."

Carrying his great grandmother's legacy of quilling art, Noah makes three-dimensional paper artwork in various genres from flowers to sneakers, animals, abstract, and pop culture such as Star Wars & Marvel. Utilizing just craft glue and printer-weight paper cut into 1/8-to-3/8-inch strips, Noah twists, rolls, curls, and cuts the paper to make these different patterns and designs which are then framed for display. As an artist, Noah loves to play with different techniques and lighting to highlight colors and create intricate textures.

2025 Major Capital Improvement Projects

Hermitage Athletic Complex - PennDOT Multimodal Transportation Fund Trail Project

The project includes constructing trails connecting Lorenwood Drive into the Hermitage Athletic Complex. The project is scheduled to be constructed in summer 2025. (Phase 2 of the project includes re-paving Lorenwood Drive and adding some additional trail enhancements to the Hermitage Athletic Complex in 2026)



Rodney White Playground Project

The project will replace the existing playground at RWOP with new equipment, an accessible poured rubber surface and new benches. The playground is over 25 years old, has reached its useful life, and cannot be repaired or refurbished. Construction was completed in May



CFA MTF Roadway Project – Hickory Field Blvd.

A \$730,000 Commonwealth Financing Authority (CFA) Multimodal Transportation Fund grant was received for a City Center public roadway project connecting the SV Mall redevelopment project to Route 18/Route 62 Roundabout. The City is working with the developer and their engineer to finalize details and anticipates to start construction this fall.

Hermitage Little League Concession and Restroom Facility Project

The city received a grant to assist the Hermitage Little League in construction of a new concession and restroom facility at the Little League Complex on Virginia Road. Project design is ongoing and anticipated to bid for construction in July 2025, with construction to be completed by the end of the year.



Hermitage Municipal Authority S. Neshannock Rd. Sewer Extension Project

The project will extend sewer lines to 93 homes and businesses along S. Neshannock Rd. and portions of Virginia Road and Miller Road and includes the purchase of grinder pumps as part of the low pressure sanitary sewer system. Construction began in April and connections to the new system will begin in the fall.

This year, 17 students from 6 local school districts learned entrepreneurial mindset and small business management skills through MIT's curriculum, 28 guest speakers, and over 20 business visits. The program culminated in the highly anticipated end-of-year competition, Demo Day Student Startup Showcase which was hosted at the eCenter@LindenPointe on Sunday, May 18th. Student-led startup teams competed for \$5,000 in prizes and were evaluated based on their business plans and pitches. Judges included Bradley Calleja (Lindenpointe Development Corporation), Lorie Hines (HopeCAT), Quyrus Epps (ELLWOOD), Frank Gargiulo (Penn State Shenango), and Ivan Meszaros (Swagelok). The first-place team, Girls Night In, won \$1,900 for their party planning subscription box that delivers decorations, activities, and party essentials. The winning team included Jiada Brodie, DeNez Hughley, Zoe Mishata of Farrell High School, and Sky Puga of Sharon High School.

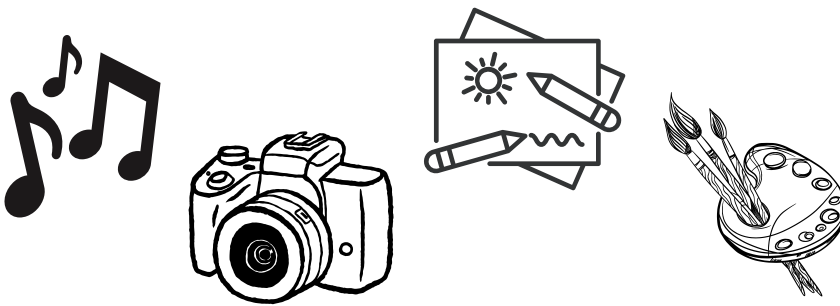

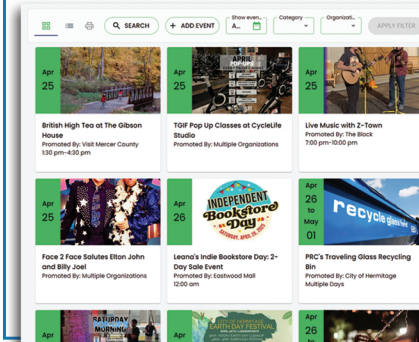

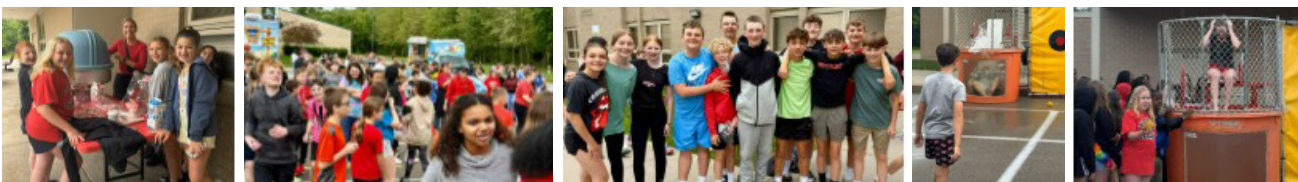

Hello everyone. As we prepare **School Real Estate** bills and **Per Capita** bills for the August 1st mailing, we are happy to inform you that there is NO increase for tax year 2025! The **Hermitage School District** taxes will remain at the face amount this year from October 1st through December 31, 2025, since the **Hermitage School District** has decided to **not** charge the 10% penalty again this year. All taxes remaining unpaid after December 31, 2025, will be filed for collection at the penalty amount.

Please notify the Tax Office if you have not received your bills.

Per Capita is a head tax on **every** resident **over the age of 18** and this year is **\$30.00**. **All residents are responsible for this tax and are expected to notify the tax office if they are not yet on our tax rolls. This includes the Wheatland neighborhood of Hermitage.** When moving from Hermitage, please notify the tax office to have your name removed.

All Homestead/Farmstead approved properties must be owner-occupied. This means that the name on the deed must match the name of the person or persons who live in that house. You may only receive the credit on your primary residence. The 2025 Homestead/Farmstead allowance for all approved home-owner parcels within the HERMITAGE SCHOOL DISTRICT is \$193.20

The Wheatland Neighborhood/ FARRELL SCHOOL DISTRICT amounts are to be announced as The Wheatland Neighborhood property owners will continue to pay School taxes for the Farrell School District.

Anyone who receives the Homestead credit and does not qualify, is required by law to notify their tax collector of the necessary correction.

Fire Department Leadership Transition



Hermitage City Manager Gary Hinkson announced on May 23 that Michael J. Wadlow has been named to replace John Flynn as Fire Marshal in the Hermitage Fire Department. Fire Marshal Flynn is retiring, effective August 1, 2025. Until then, beginning on June 2, 2025, Mr. Wadlow will serve as Fire Marshal-designate

reporting to Fire Marshal Flynn in a transition period. He will assume his duties as Fire Marshal on August 1, 2025. Mr. Wadlow has over 21 years of experience in fire and emergency services and is a 4-year member of the Hermitage Fire Department where he held the rank of Lieutenant until this appointment. Prior to residing in Hermitage, he was employed as a fire fighter with the City of Warren, PA Fire Department and for 14 years as Chief of the North Warren Volunteer Fire Department. He has worked for Ellwood Crankshaft Group since 2003, most recently as Director of Maintenance & Facilities.

He has served in the U.S. Army and Army Reserve from 2002-2014, is a combat veteran of Operation Iraqi Freedom, and received several combat and achievement medals and awards.

Hinkson said "Mike Wadlow has a true love for fire service along with the technical and administrative knowledge necessary to be Fire Marshal."

At the same time the City wishes to thank Fire Marshal Flynn for his over 33 years of service with the Hermitage Fire Department, the last 10 years as Fire Marshal. He has cultivated an atmosphere of cooperation with area departments related to mutual response to incidents and shared training opportunities. Vehicle Code and Traffic Safety

Paul Miller's Law (Senate Bill No. 37) took effect June 5, 2025. Section 3716.1(a) of the PA Vehicle Code now prohibits the use of hand-held interactive mobile devices (cell phones) while driving a motor vehicle. Prohibited behavior includes holding, dialing, or answering by pressing more than one button, or reaching for an interactive

mobile device in a manner that requires the driver to become unseated from the driving position or unrestrained by a seat belt.

This section applies to any motor vehicle operating upon a highway, including while temporarily stationary in traffic, or

stopped at a red traffic signal or stop sign. It does not apply if the driver has moved the vehicle safely out of the flow of traffic, to the side of or off of a highway, and is stopped in a location where the vehicle can safely remain stationary. Additionally, it does not apply if using an interactive mobile device that is necessary to communicate with a law enforcement official or other emergency services to prevent injury to persons or property.

Per statute, only warnings may be issued from June 5, 2025, until June 5, 2026. On or after June 6, 2026, this offense will be punishable by a \$50 fine.
